**MEMORANDUM AND ARTICLES OF ASSOCIATION:**  
(Definitions and General Articles #3)

*The Hong Kong Electronics Industries Association Limited shall consist of merchants, manufacturers, assemblers, publishers, industrialists, importers and exporters and other including companies, partnerships, sole proprietorships, unincorporated associations and societies engaged or interested in the electronics industry (as defined in the Memorandum of the Association of Hong Kong). Applications to Membership shall require to satisfy the Committee as to their qualifications (if so required) for membership prior to election. The Association shall be international in its character and, subject to the provisions of the General Memorandum and Articles of Association, membership shall be open to persons of all races and nationalities.*

*We, the undersigned, hereby wish to apply for membership in the Hong Kong Electronic Industries Association Limited, and, if accepted, agree to abide by the rules and regulations of the Association as may be laid down by the Executive Committee from time to time.*

## **(1) PATRON MEMBERS**

The Membership fee for Patron Member is HK\$200,000. This is a one-time fee offering the applicant permanent membership and the right to appoint a senior company official to sit on the Executive Committee of the Association. Acceptance of Patron Members, which must be corporations, is subject to prior approval by the incumbent Executive Committee. There is a strict limitation to the number of Patron Members allowed on the board.

### ***(i) Voting Patron Members***

A Voting Patron Member may nominate a member of its Board of Directors, Partners, Officers, Staff and Employees to sit on the Executive Committee. It enjoys all the same rights of Corporate Members and has the right to vote and be nominated for election as one of the following Office Bearers such as Chairman, Vice-Chairman, Secretary or Treasurer subject to the terms and conditions of the Articles of Association.

### ***(ii) Non-voting Patron Members***

A Non-voting Patron Member, though maintaining permanent membership, may choose, on its own accord, not to nominate a member of its board, partners, officers or staff to sit on the Executive Committee; forego its right to vote or be elected to be a Member of the Committee or be nominated for election for any one of the Office Bearer Positions. A Non-voting Patron Member may, at a future date of its own choosing, apply to the Executive Committee to become a Voting Patron Member and nominate one of its directors, partners, or staff to sit on the Executive Committee but approval is subject to the discretion of the Committee under the Terms and Conditions outlined in the Bye-laws for acceptance of Committee members as may be applicable at the time.

## **(2) FULL MEMBERS**

### ***(i) Corporate Members***

All Hong Kong-incorporated\* companies manufacturing or trading in all kinds of electronics products: from consumer products to industrial equipment to parts and components, may apply for FULL HKEIA membership. All Full Members shall have equal voting rights and the right to be nominated or elected to join the Executive Committee –and to be elected to be an Office Bearer of the HKEIA– on condition that they must have been a full member for at least two consecutive years.

The annual Membership fee for FULL CORPORATE MEMBERS is HK\$ 3,000, regardless of size. Members agree to be totally liable for full payment when receiving an invoice from the Association. Cancellation of membership will only be accepted upon written request three months prior to expiration.

(\* Companies may be headquartered or originally from overseas countries but they must be registered or incorporated with the Hong Kong Registrar of Companies.)

### ***(ii) Overseas Members***

Companies which are based or incorporated overseas only may also join the HKEIA as Overseas Members which are also full membership with voting rights. The entrance fee and Annual membership fee are the same as full corporate members at HK\$1,500 and HK\$3,000 respectively. However, unless they are based in Hong Kong, they will not have the right to be nominated or elected to the Executive Committee or to be elected as Office Bearer.

### ***(iii) Associate Members***

All societies/ trade organizations/ tertiary institutions or companies which are NOT in the electronics field but are closely associated with it. Fees and rights are the same as full members.

## **(3) OTHER TYPES OF MEMBERSHIPS**

### ***(i) Individual Members***

All professional, academics or individual persons engaged in or associated with the electronics field may join the HKEIA as Individual Members. Individual Members are not full members and do not have the same voting rights as Full Members and also cannot sit on the Executive Committee nor be elected to be Office Bearers. However, they may be nominated to join one of the many Sub-Committees as a member only and may also be nominated to join in on Ad Hoc sub-committees. To have the same voting rights and sit on the Executive Committee, Individual Members must become a Full Member and pay the full membership fees.

### ***(ii) Affiliate Members***

Affiliate members MUST be a subsidiary (at least 51% owned) company of a full PATRON or CORPORATE member. The joining fee is HK\$500, which includes a HK\$250 one-time entrance fee and first year membership of HK\$250. Annual membership fees are also HK\$250 (unless changed by the Executive Committee). Affiliate members have no voting rights and cannot nominate nor receive nominations to sit on the Executive Committee.
